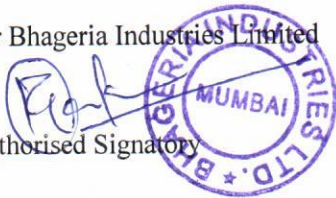

NOTICE is hereby given pursuant to the provisions of Section 110 of the Companies Act, 2013 (the 'Act') read with the Companies (Management and Administration) Rules, 2014 that the Resolutions as set out in the Notice of Postal Ballot, are proposed to be passed by way of postal ballot including voting by electronic means ('e-voting').

Members are informed that the Company has completed despatch of the postal ballot notice, in respect of the aforesaid resolutions, alongwith postal ballot form on September 14, 2016 to the members whose names appeared in the register of members/register of beneficial owners as on September 02, 2016 (End of Day), (i) through email at their registered email ID and (ii) wherever the email ID is not registered through prescribed mode.
